#### **ELECTION PROCEDURE**

All Class A Members may cast five (5) votes for the five (5) general director seats for each unit or lot they own. Class A Members living in a neighborhood without a local association may cast one (1) additional vote for the one (1) fixed director seat, who will serve as Chairperson of the Neighborhood Advisory Committee. Each seat shall have an Alternate Director. The candidates receiving the highest number of votes for each seat will be elected as a Director. The candidates receiving the next highest number of votes shall be elected as an Alternate Director. You may vote in person during early voting or on election day. If you cannot attend in person, you may request an absentee ballot as explained below.

### **ELIGIBILITY TO VOTE**

To be eligible to vote, a member must be in good standing, which means that you are not more than ninety (90) days delinquent with assessments. A photo identification card (such as a driver's license or passport) is required before you can cast your vote. Your identification will be used to confirm your ownership at the Hammocks. You must sign a roster indicating you are the authorized voting Member for your lot or unit. If you own your lot or unit through a company, your name must appear on <u>www.sunbiz.org</u> as an authorized agent for that company owner. If owned in the name of a trust, the trustee must cast the vote.

#### **ABSENTEE BALLOT PROCEDURE**

Absentee ballots can be requested by contacting the Hammocks Hotline at 1-888-261-9020 or via e-mail to <u>hammockshotline@gmail.com</u>. Upon request, an original ballot secured with a control number and additional security measures will be mailed to you. The absentee ballot package will include instructions on how to properly fill it out and return it to the Association. Absentee ballots must be received by the Association before election day.
